President Don H. Roberts called the meeting to order at 700 p.m.

Upon a motion by President Roberts, seconded by Director Zagrzecki, after a full discussion and the question being put to the Board, the Board voted unanimously to Adopt Resolution Implementing 20% Penalty for Delinquent 2022 Taxes and Contracting with Attorneys for Delinquent Tax Collection.

Upon a motion by President Roberts, seconded by Director Hart, after a full discussion and the question being put to the Board, the Board voted unanimously to Accept Certification of Unopposed Candidates and Adopt Order Declaring Unopposed Candidates Elected to Office and Cancelling Directors Election Approve Minutes of Prior. The Board of Directors declares the following unopposed candidate to be elected to the office of director of the District.

#### **OPERATOR'S REPORT**

Mr. Jim Ferguson presented the Operator's Report, a copy of which is attached as Exhibit "C." Mr. Ferguson discussed the status of District facilities and repairs in progress. The board discussed progress of the WWTP Improvement Project (aeration basin cleaning/air system replacement). Mr. Ferguson said that the January Pumpage is 8,656,000. Water accountability for the YTD is 92.37% and the MTD is 90.65 %. Online bill pay is at 64.70%.

Mr. Ferguson reported WDM's pending transition of Utility Billing Services from AVR to Starnik. WDM will continue to use First Billing for online payments. Customer's will incur a \$1.00 fee for E-check payments. Mr. Ferguson also informed the District that NHCRWA (North Harris County Regional Water Authority) plans to extend water line to HC WCID 92 IN 2027. The Board requested Mr. Cowart to possibly set up a meeting with NHCRWA to discuss plan of installing a surface water supply line and how it conflicts with the Districts pursuit to construct a 4<sup>th</sup> water well.

The board asked Mr. Ferguson to let the Board know what the most common reasons (top 5 reasons) customers call in for HC WCID 92.

#### **GARBAGE REPORT**

Mr. Cowart presented the garbage report, a copy of which is attached as Exhibit "D." Mr. Cowart said that Best Trash is only charging, HC WCID 92, half of diesel surcharge, charging District less. In March, the District will need to make sure we do not pay any Cost-of-Living Increase.

#### **RATE ORDER**

#### RECREATION ADVISORY COMMITTEE REPORT

Mr. Cowart presented the Recreation Advisory Committee Report. Picnic tables should be delivered towards the end of this month and will begin mulching and planting in the next few weeks.

Mr. Cowart presented the Engineer's Report, a copy if which is attached as Exhibit "E." Regarding the height, of Legacy Charter School structure's on the two tract has been addressed at this time. Mr. Adam is addressing the comments of The City of Houston currently about the Proposed Water Well No. 4. HC WCID does not have permits to drill a well now.
